This is a legally binding contract between Theory Media Group (hereafter referred to as TMG), located at 414 Buchanan Rd. Griffin, GA 30224, and

PRICING

The available video packages and pricing are as follows:

PACKAGE A

Wedding Ceremony* Only

1. \$495 – One videographer.
2. \$649 – Two videographers.
3. \$795 – Three videographers.

PACKAGE B*

Wedding Ceremony and Wedding Trailer (Music Video)*

1. \$795 – One videographer. (For both Wedding Ceremony and Wedding Trailer).
2. \$1,049 – Two videographers. (Two for the Wedding Ceremony, and one for the Wedding Trailer).
3. \$1,395 – Two videographers. (Two for the Wedding Ceremony, and two for the Wedding Trailer).

* **Wedding Ceremony** includes footage solely of the wedding ceremony.

* **Wedding Trailer** includes footage before the wedding (wedding parties getting prepared), wedding ceremony, and reception. All of the footage is edited together with your song of choice. Max length of video is 5 minutes. Longer videos can be negotiated.

* **Package B** includes two separate videos: The Wedding Ceremony, and the Wedding Trailer.

DVDs: Two DVD's Included; free digital format uploaded to Google Drive for download and YouTube for viewing purposes.

Additional copies: \$10 per copy.

Miscellaneous Fees

Additional Footage: If there is additional footage you would like, e.g. Rehearsal, etc. This can be negotiated.

Driving Costs: Free if within 50 miles of TMG's office.
\$0.50 per mile after the first 50 miles (there and back).

Room and Board: If TMG has to rent a hotel room for travel (further than 200 miles), additional fees apply. (Can be discussed before finalized).

A non-refundable deposit of \$[_____] (Minimum 50% of total cost) is payable at the time of signing the contract. The balance is due at least 14 days before the wedding date.

In the event that more than one client wishes to book wedding services on the same day, preference will go to the first client to pay the deposit. Rescheduled weddings will only be accommodated if the new date does not conflict with another booked wedding.

TMG will be the exclusive professional videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or get in the way of the professional coverage.

It is the client's responsibility to secure access to areas for videography. TMG will not be responsible for coverage lost due to access restrictions.

Creative aspects such as shooting and editing style are at the discretion of TMG.

TMG will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, etc.

TMG reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health. In this event all monies paid will be refunded in full.

Any liability on the part of TMG will be limited to the amount of monies paid.

Upon taking possession of the finished product, the client must inform TMG of any technical or other problems with the video within 7 days. After 7 days, if no notification has been received, the client will be deemed to be satisfied with the product.

Copyright will be owned by both the client and TMG.
